## 4. FIRST AID MEASURES

## 5. FIRE FIGHTING MEASURES

### Suitable Extinguishing Media:

Not combustible, however, if material is involved in a fire use: Fine water spray, normal foam, dry agent (carbon dioxide, dry chemical powder).

Non-combustible material. Decomposes on heating emitting toxic fumes including those of oxides of sulfur .

Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to products of decomposition.

## 6. ACCIDENTAL RELEASE MEASURES

### Emergency procedures/Environmental precautions:

If contamination of sewers or waterways has occurred advise local emergency services.

### Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in dust. Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust. Collect and seal in properly labelled containers or drums for disposal. Wash area down with excess water.

## 7. HANDLING AND STORAGE

**Precautions for safe handling:** Avoid skin and eye contact and breathing in dust. Avoid handling which leads to dust formation.

**Conditions for safe storage, including any incompatibilities:** Store in a cool, dry, well ventilated place. Keep containers closed when not in use - check regularly for spills.

## 8. EXPOSURE CONTROLS/PERSONAL PROTECTION
