4. FIRST AID MEASURES

Inhalation:

5. FIRE FIGHTING MEASURES

Combustible liquid.

Special protective equipment and precautions for fire-fighters:

On burning will emit toxic fumes, including those of oxides of carbon. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion. Keep containers cool with water spray.

6. ACCIDENTAL RELEASE MEASURES

Emergency procedures/Environmental precautions:

Clear area of all unprotected personnel. Shut off all possible sources of ignition. Wear protective equipment to prevent skin and eye contact and inhalation of vapours/dusts.

Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Slippery when spilt. Avoid accidents, clean up immediately. Work up wind or increase ventilation. Contain-do not allow material to enter waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal.
